**What to wear:**

Suitable clothing for the weather i.e. rain coat and layers should be supplied. For children without their own we have riding hats to borrow. They must however wear suitable footwear such as wellies or other small heeled boots covering the ankle. **NO TRAINERS OR SHOES.** Long trousers must also be worn. Children considered unsuitably dressed may not be able to take part.

**What to bring:**

If coming for a pony day you need to supply children with lunch and any snacks and drinks they may need. Horseshoe club need snacks & drinks. Please make sure they have any medication they may require e.g. allergy medicine and that the instructors are aware.

**Terms & Conditions:**

1. Horse riding is a risk sport, participation therefore holds potential danger.
2. Horses are sometimes unpredictable and do not always respond as expected.
3. We advise all persons participating in equestrian activity to ensure that they have adequate personal accident insurance.
4. While riding, children must wear a t-shirt or top with long or short sleeves (no strappy tops), long trousers, suitable footwear and no jewellery of any description.
5. We require 48 hours notice of cancellation or full charge may be made.
